Application is hereby made for permission to install an underground electricity service under the footpath to the abovementioned site.

The cable will be installed in accordance with Council conditions listed below and all relevant permit and restoration fees will be paid in accordance with Council's Fees and Charges.

Conditions:

The electricity service is to be installed as follows:

1. The cable is to be laid at a minimum depth of 900mm below the surface of the footpath.
2. Where the cable will be laid across a water pipe it shall be under the water pipe with minimum clearance of 300mm to the underside of the pipe.
3. Concrete tiles at least 390mm x 190mm x 40mm are to be laid immediately over the cable and an orange marker tape bearing the legend "CAUTION ELECTRIC CABLE BELOW" is to be laid in the backfill 400mm above the concrete tiles. Where the cable crosses under a water pipe the tiles are also to be under the pipe.
4. The underground service connection is to be laid at right angles to the property alignment. See diagram on back of this page.
 - a) Service pole located adjacent the property to be served:- The underground service is to be laid at right angles to the property boundary from the pole;
 - b) Service pole not located as in (a):- The underground service is to be laid from the Ergon Energy pole parallel to and directly beneath the line of Ergon Energy's reticulation wires until opposite the boundary of the property to be served, whereupon the service will be laid at right angles to the property boundary. This will result in the service entering the property at its common boundary with the adjacent property.
5. The location of the underground service is to be clearly marked by a distinctive marking with yellow paint on the pole and by a standard marker bearing the wording "UNDERGROUND ELECTRIC CABLE" or similar, suitable wording on the street alignment approximately over the cable.
6. The applicant is responsible for the preservation of public safety during the construction of the work and for the erection and maintenance of all barricades and lights;
7. The excavation is to be properly backfilled and re-compacted to the satisfaction of the Director of Environment and Operations.
8. Scale Plan required.
9. A traffic management plan must be submitted with this application prior to approval.
