Dear Ken,

Delle Baite Brothers and Sure Water pty ltd have been served with notices that the Department of Main Roads intend to resume a strip of land 9m wide adjacent to the Bruce Highway. The purpose for this is to provide an overtaking lane for south bound traffic between Ayr and the giddy road intersection.

Delle Baite Brothers and Sure Water pty ltd are lodging objections to the resumption on the following grounds

- The double line required for the overtaking lane will severely restrict access between our properties. In the case of cane haulage it will be much more difficult to cross the road to deliver cane to the cane delivery siding on McDesme road. All other farming vehicles will have more difficulty in operating between the various adjacent farming blocks.
- The proposed development will obstruct drainage development for Sure Waters cane land and will cause a loss of approximately 5 acres of production.
- The overtaking lane will substantially increase the risk of accidents as is only several hundred meters before the cane train crossing at the cross roads of McDesme and Giddy road. Sucrogen are already concerned about the dangers at this intersection which would be used by 12 trains a day normally and up to 18 trains a day.
- In the proposed resumption of the land there is a Blue Gum tree that is considered an icon of the district. We are concerned that this tree will have to be removed with the proposed development.
- Finally there is no need for vehicles overtaking within such a short distance of the speed limit sign of 70km at the Burdekin Bridge.

We respectfully request the council to support our objection to this proposed overtaking lane. If the council sees fit to support us then we propose a meeting with the Council and Department of Main Roads on site when the final plans are drawn.

NOTICE is hereby given that in pursuance of the provisions of the Acquisition of Land Act 1967, the Transport Planning and Coordination Act 1994, and the Transport Infrastructure Act 1994, the Chief Executive. Department of Transport and Main Roads ("Chief Executive"), as constructing authority for the State of Queensland, intends to take the land described in the attached schedule and shown on attached plan R208-3 for the purpose of transport, in particular, road purposes.

The decision to commence the process for taking the land was made by Regional Director (Northern), Department of Transport and Main Roads, as the delegate of the Chief Executive.

Attached is Background Information for the proposed taking of the land, together with a brochure entitled "Your Property - Your Rights" which explains the acquisition process.

If you wish to object to the taking of the land, you must send an objection in writing to Regional Director (Northern), PO Box 1089, Townsville Qld 4810 on or before 14 December 2011. Regional Director (Northern), Department of Transport and Main Roads is the delegate of the Chief Executive appointed to hear objections to the proposed resumption.

The written objection must contain;

(a) the grounds of the objection;

(b) the facts and circumstances relied on by you to support the grounds; and

(c) whether you wish to appear before the Chief Executive's delegate and be heard in support of the grounds of the objection.

Any matter pertaining to the amount or payment of compensation is not a ground of objection.

If you state in your written objection that you wish to be heard in support of the grounds of your objection you may appear and be heard at the office of Regional Director (Northern), Floor 1, 146 Wills Street, Townsville Qld 4810 on 15 December 2011 at 10:00am. You may appear personally or by counsel, solicitor or agent.


The Chief Executive is willing to negotiate to acquire by agreement, or failing agreement, to treat as to the compensation to be paid and all consequential matters.


If the land is taken, then a claim for compensation may be served on the Chief Executive only within three years after the day the land is taken.

The Chief Executive may accept, and deal with, a claim for compensation served by you more than three years after the land is taken if the Chief Executive is satisfied it is reasonable in all the circumstances to do so.

If the Chief Executive does not accept a claim served by you more than three years after the land is taken you may apply to the Land Court to decide whether it is reasonable in all the circumstances for the Chief Executive to accept the claim.

Note: section 20(2A) of the Acquisition of Land Act 1967 provides that, in assessing compensation, a contract, licence, agreement or other arrangement (relevant instrument) entered into in relation to the land after the notice of intention to resume was served on you must not be taken into consideration if the relevant instrument was entered into for the sole or dominant purpose of enabling you or another person to obtain compensation for an interest in land created under the relevant instrument.

### **Natural Disaster Insurance**

Councils may be contacted in the near future by their insurance broker for authority to provide asset information necessary for assessment of Queensland's natural disaster insurance arrangements.

The Commonwealth's Natural Disaster Relief and Recovery Arrangements (NDRRD) Determination requires each State to undertake a natural disaster insurance assessment. The assessment is to be conducted by an independent specialist and examine whether States have reasonably adequate capital or access to capital to fund liabilities or infrastructure losses arising from natural disasters. Assessments will be reviewed by the Commonwealth Department of Finance and Deregulation.

The LGAQ is continuing to assist Queensland Treasury with preparation of the Queensland assessment. Each State's assessment must also include information on local government assets and insurance arrangements.

Queensland Treasury has engaged the firm Finity Consulting to undertake the Queensland assessment. To complete the assessment, Finity Consulting will require information in relation to relevant assets, losses and insurance arrangements. This information can be readily provided to Finity by insurance brokers but they will require approval from councils to do so.

Brokers will be contacting their council clients in the near future seeking approval to work with Finity Consulting and provide necessary asset and insurance information. The LGAQ encourages councils to provide the approval at the earliest opportunity.

# **Queensland Floods Commission of Inquiry Final Report Findings**

The release of the Final Report of Queensland Floods Commission of Inquiry has responded positively to local government concerns.

The Final Report of the Queensland Commission of Inquiry, released today, has backed local government's view that the State Government should have a key role in the production of flood studies and flood mapping.

The Commission's Final Report also found no adverse findings against an individual council or local government as a whole.

The Final Report includes findings and recommendations in response to matters identified in the LGAQ's Submissions to the Commission, including:

#### Responsibility for flood mapping

The Commission agrees that catchment wide flood studies are needed for many areas and that the three levels of government should co-operate to ensure they are produced. The report emphasises the key role of the State Government in flood mapping in line with LGAQ's submissions.

#### Statutory immunity

The LGAQ congratulates the Commission's endorsement of the State Government proposed investigation into the viability of introducing legislation regarding statutory immunity, and that the investigation is undertaken in consultation with local government.

Resourcing and technical support for local government

While the Commission stated that it was not in a position to determine how the three tiers of government should allocate their resources, the LGAQ maintains that long term financial and technical support is required to support local governments to successfully implement many of the Commission's recommendations.

#### Regulation of levees

The Commission agrees that the Queensland Government should consult with councils to determine an effective method for regulation of the construction of levees in Queensland.

The Association also welcomes the Commission's closing remarks regarding broader flood mitigation responsibility and the potential for future investigations regarding State agency responsibilities. Such an investigation regarding State agency responsibility and mandate will undoubtedly reduce gaps in policy and inter-agency inconsistencies.

#### **Funding**

The State Government has announced that \$40 million will be allocated over the next three years from the Local Government Grants and Subsidies Program (LGGSP) for councils to implement the recommendations of the Report. The LGAQ will argue that new money is required not a re-allocation from an existing program. The LGGSP provides \$45 million per annum to councils with reduced financial capacity and is insufficient to meet existing infrastructure needs let alone the work required to be undertaken as a result of the Commission's recommendations.
