Hi,

We are Q-Ride Service Providers for the Department of Transport. Q-Ride is a competency-based training and assessment program delivered only by Q-Ride registered providers. It is designed to ensure learner riders continue training until they have attained each of the competency standards that have been developed by the Department of Transport for satisfactory performance. The focus of Q-Ride Training is on the development of skills necessary to safely ride a motorbike and the attainment of a positive attitude toward using those skills whilst riding. We currently provide this training and assessment in Townsville, Mount Isa, and other small regional towns. Over the past year we have had a number of residents from the Burdekin travel to Townsville for this training and we believe there may be some benefit in bringing the training to Ayr/Bowen .

To enable us to do this training, we need the use an area such as a large car park, show ground, school car park etc

that has a suitable surface for the manoeuvres required. These activities are not done at speed but rather teach skills such as slow riding, turning and braking. It is also not a noisy activity. The Q-Ride program aims to keep new riders safe.

We visited your offices last week and identified that Anzac Park would be perfect for our training.

My husband and I own and deliver the training. We provide all bikes and safety gear. We are audited twice a year by an external auditor who ensures our policies, procedures and record keeping are compliant and then again by the Department themselves to ensure our training program is delivered as agreed.

We put in place safety bollards and tape, keep the area neat and tidy and of course make sure we left the premises as found them. We have public liability insurance and there are no noise issues with the training. We are also happy to provide any references you require or answer any of your concerns.

I have attached the link which shows we are register provider with the Department of Transport. Q-Ride registered service provider (PDF, 61 KB)

Our training courses run for approximately 5 hours and we normally run these from around 8am to 1pm but we are flexible with times. We don't require any other facilities (unless we can have access to toilets) but this is not a requirement. We would obviously pay a fee for the use of this area as advised by you.

Dear Mayor

Thank you for your letter dated 17 December 2014 regarding development opportunities for the Burdekin district. I apologise for the delay in responding and for not being able to meet you during your visit to Canberra.

I am pleased that you were able to meet with staff from my office to discuss current development opportunities within the Burdekin Shire and the wider Townsville region.

The Australian Government (the Government) is committed to supporting local governments to provide the infrastructure and services that drive productivity. In 2014-15 the Government will provide \$2.3 billion in untied funding to local government under the Financial Assistance Grant programme. The Burdekin Shire Council will receive \$3,259,723 under this programme. Under the Roads to Recovery programme the Burdekin Shire Council will receive \$2,613,131 in funding over the next five years.

The 2014-15 Budget outlined a \$50 billion investment across Australia to deliver vital transport infrastructure for the 21st Century. This includes many large scale commitments which will trigger more than \$125 billion in infrastructure investment with a significant boost to road funding at the local level. I encourage the Burdekin Shire Council to seek funding for relevant projects under programmes such as the Black Spot programme, where the Government has committed \$500 million from 2014-15 to 2018-19, and the Bridges Renewal programme, where \$300 million has been committed over the five years from 2014-15.

Round Two of NSRF will open on 1 May 2015. The Regional Development Australia (RDA) Townsville and North West Queensland Committee is available to assist you to develop project proposals. The Executive Officer for RDA Townsville and North West Queensland can be contacted on 07 4410 3655.

The Government is committed to unlocking the full economic potential of Northern Australia and recognises that local government, including the Burdekin Shire Council, has an important contribution to make to this work.

As part of our systematic and rigorous approach, the Government has established a Taskforce to prepare a *White Paper on the Development of Northern Australia*. It will build on the key themes discussed in the Green Paper and set out a well-defined programme of initiatives and reforms to grow the north. The White Paper will also include a 15 year rolling priority list of infrastructure projects identified by Infrastructure Australia to support growth. I encourage your continued involvement in this initiative.
