Re: Arrangements for the Caretaker Period during the 2016 Local Government Quadrennial Elections

As you may be aware, the 2016 Local Government Quadrennial Elections will be held on Saturday, 19 March 2016.

I am writing to remind you of the caretaker provisions which are outlined in Part 5 of Chapter 3 of the *Local Government Act 2009*, and I encourage you to make Councillors and Council officers fully aware of the provisions in preparation for the elections.

The caretaker period commences when the Electoral Commission of Queensland (ECQ), as the returning officer, publishes the notice of the quadrennial elections calling for nominations and will conclude when the ECQ publishes the declaration of poll notice for your Council.

During the caretaker period, your Council must not publish or distribute election material. Election material is anything able to, or intended to:

- influence an elector about voting at an election, or
- affect the result of an election.

Additionally, the Council should prepare for the caretaker period by planning to make any major policy decisions before or after the election period. A major policy decision includes a decision:

- about the appointment, termination or remuneration of the Chief Executive Officer
- to enter into a contract where the total value is more than the greater of the following:
  - \$200.000. or
  - 1% of the Council's net rates and utilities as stated in the Council's most recent audited financial statements.

# Arrangements for the Caretaker Period during the 2016 Local Government Quadrennial Elections

#### **Purpose**

The purpose of this bulletin is to provide advice to local governments on the limitations on publishing election material and making major policy decisions during the caretaker period.

#### What the legislation says

The caretaker provisions of the *Local Government Act 2009* and *City of Brisbane Act 2010* are outlined in Part 5 of Chapter 3.

The caretaker period for a local government is the period during local government elections that starts on the day when public notice of the holding of the election is given. The caretaker period ends at the conclusion of the election. The Electoral Commission of Queensland will advise when the caretaker period commences and when it will conclude for each local government.

#### **Election Material**

A local government must not, during a caretaker period for the local government, publish or distribute election material. Election material is anything able to, or intended to:

- · influence an elector about voting at an election or
- affect the result of an election.

#### **Major Policy Decisions**

A local government must not make a major policy decision during a caretaker period for the local government. However, in exceptional circumstances, a local government may make a major policy decision in the public interest during the caretaker period, once approval has been given by the Minister.

Under the legislation, a major policy decision means a decision:

- about the appointment, remuneration or termination of a chief executive officer of the local government
- to enter into a contract greater than \$200 000 or one per cent of the local government's net rate and utility charges (as stated in the local government's audited financial statements included in the local government's most recently adopted annual report)—whichever is greater.

A major policy decision made by a local government during a caretaker period will be invalid if the Minister's approval has not been sought prior to making the decision. A local government may be liable for damages for contracts entered into for major policy decisions during the caretaker period without the Minister's approval.

#### Planning for the caretaker period

Local governments should prepare for the caretaker period by planning to make any major policy decision before or after the election period.

However, it is understood that unforeseeable events can result in a local government having to make major policy decisions during the caretaker period. Accordingly in exceptional circumstances, local governments can apply to the Minister for approval in the following circumstances if the:

- need for the decision was unforeseeable
- decision is essential to the functioning of the local government
- · decision cannot wait until the end of the caretaker period
- · decision is in the public interest.

The Minister will decide on a case-by-case basis whether the decision meets the exceptional circumstances requirement of the *Local Government Act 2009* and the *City of Brisbane Act 2010*.

#### **Applying to the Minister**

The Minister will deal with applications as a matter of urgency. To enable this to happen, it would be appreciated if all applications could be addressed to your nearest regional office for local government.

Each application should include:

- details of the proposed major policy decision
- an explanation of how circumstances of the decision are exceptional
- an explanation of how the decision is in the public interest.

The Department has established administrative processes to ensure applications from councils can be dealt with in a timely manner.

We have been working with the ECQ and welcome their proactive approach taken towards facilitating the needs of individual local councils. Now is the time to raise your concerns.

The LGAQ has been meeting regularly with Electoral Commission Queensland (ECQ) in recent months, working on forward planning for the local government quadrennial elections due to be held 19 March 2016. We welcome the proactive approach taken by ECQ towards facilitating the needs of individual local councils.

ECQ recently corresponded with councils in relation to planning for the elections - including a letter and questionnaire seeking input into the planning process. The questionnaire was different depending on whether it was addressed to councils conducting an attendance ballot or a full postal ballot.

The ECQ is seeking to work co-operatively with councils in order to better meet the reasonable expectations of electors, while ensuring efficient use of limited resources, and meeting the standards required for the public to have confidence in electoral outcomes.

Over 50 councils have responded to the ECQ correspondence or commenced a dialogue in some form regarding election preparations. The ECQ are currently investigating alternatives to provide efficiencies for the election including utilising council facilities where these premises are suitable, such as:

- an office for the Returning Officer
- polling booths and pre-poll centres

In support of the **Better Councils, Better Communities** campaign in April the Association launched a performance benchmarking service for members called **Ready.Set.Go.** 

A second tranche of performance indicators was released in July and was automatically added to your councils' data within the service. Available through LG Online these new indicators include:

- Three new demographic measures
  - · Working Capital Ratio
  - Reliance on Rates & Charges
  - · Reliance on Operational Grants
  - Time Lost to Accidents per Employee
- Population Serviced per Employee
- Asset Consumption Ratio
- Calculated Replacement Cost (CRC) of Asset Base per Capita
- Two new service level measures

The LGAQ circular of the 23<sup>rd</sup> July encourages feedback and suggestions of further performance measures for inclusion, these would be appreciated before *Friday 9<sup>th</sup> October*.

The Association is committed to releasing a further set of performance benchmarks and will be using the feedback received from councils to help determine this next release. This service is being provided to members at no cost, and is a benefit of councils' ongoing membership of the Association and support for LG Online.

Data for the 14/15 financial year will be added to the service once QAO audit processes are completed. Councils who would like to customise their performance targets for the non-statutory measures are also encouraged to contact the Association.

A final call is also being made for expressions of interest in a targeted performance measurement project which will involve the sharing of local performance data at a more targeted/operational level and will require a higher degree of council commitment. This project will commence shortly.



The experience gained by the WFTD clients in this proposed project would be invaluable, and we trust that the council could partner with us through this donation, and enable this larger building project to come to fruition.



Thank you for your letter of 17 September 2015 about the upgrade of the Ocean Creek boat ramp. As discussed by telephone, here is a summary of the issues and constraints confronting Burdekin Shire Council (BSC) and the Department of Transport and Main Roads (TMR) in upgrading the boat ramp.

The Burdekin coast offers no waterways suitable for all-tide boating facilities, without multimillion dollar dredging of coastal creeks or the Burdekin River entrance and high maintenance costs. TMR provides several part-tide ramps in the Burdekin region and all-tide ramps not far distant – Townsville to the immediate north and Bowen boat harbour to the immediate south.

I have enclosed an email from Mr Peter Wood, Manager (Infrastructure Projects), TMR, to Volunteer Marine Rescue (VMR) Burdekin, which contains a Google Earth image of the boat ramp at Ocean Creek in the northern part of the Burdekin district that is scheduled for upgrade in 2015–16, at which time ownership will be transferred from BSC to TMR. BSC has advised that this project is its highest priority for boating infrastructure. TMR conducted a hydrographic survey in June 2014. The project was announced publicly in January 2015 for completion by June 2016.

Extensive consultation took place with VMR Burdekin and BSC, resulting in both endorsing TMR's proposed configuration for the ramp upgrade in February 2015. The design was completed on 1 June 2015 and is pending approvals prior to tendering. Approvals applications are ready to submit.

Since February 2015, some members of VMR Burdekin have lobbied for TMR's proposed configuration to be significantly altered. I have enclosed a letter dated 10 September 2015 from VMR Burdekin to Mr Wood for your information.

Cost is not the primary driver for TMR proceeding with its current design, but rather the available creek width, engineering feasibility and environmental constraints.

However, VMR Burdekin has revoked its previous endorsement and proposed a new (unworkable) site configuration.

TMR's constraints and proposals for the upgraded boat ramp include:

- The whole site/area lies within a Fish Habitat Area B (FHA). Because of a specific exclusion from the FHA, TMR/BSC can develop the existing ramp to +/-50 m either side. Mangroves (25 m²) can be removed as part of an expansion of the existing ramp. Any mangrove clearance for a new ramp would require assessment of a development application, with priority given to upgrading the existing ramp first. Further filling or reclamation on intertidal flats is not permitted for creation of new parking and access roads. Removal of material from the extensive intertidal creek flats/banks is not permitted, other than a basin in the creek immediately adjacent to the ramp.
- The ramp configuration option now proposed by VMR Burdekin (described in text at letter dated 10 September 2015) is not possible (short of rescinding a large tract of FHA), owing to:
  - BSC would not be given approval to conduct reclamation of the approaches (inter-tidal flats) to a relocated ramp in the FHA, even if within 50 m of the existing ramp. There is no point in TMR building a ramp with no shore access. Foreshore reclamation for vehicle access, even if approved, would be costly for BSC.
  - TMR is limited to upgrading the existing ramp, owing to the Department of Agriculture and Fisheries (DAF) preference to disturb the environment at one place (even on an increased footprint) rather than create a new/separate environmental disturbance.
- TMR's upgraded ramp design is carefully configured (with two grades) to maximise
  access at lower tides. Ocean Creek is not navigable at extreme low tides. The site
  proposed by VMR Burdekin 30 metres downstream, on detailed examination of
  bathymetry, offers no advantage over the existing ramp site.
- An expanded basin can be dug in the creek at the base of the ramp. The centreline of the basin needs to coincide with the centreline of the creek, to minimise infill and maximise self-flushing from tidal flow. The basin cannot cut into mangroves on the opposite bank. Nor can the basin encroach to the west into the tidal flats (as proposed by VMR Burdekin) owing to DAF prohibition on material removal from banks of the creek in the FHA. The basin can be dug in the creek larger initially using a barge/pontoon mounted excavator, then maintained using a boat-ramp-mounted, long-arm excavator. TMR would cover the initial capital costs of basin excavation. Ongoing maintenance of the basin would be carried out by BSC under a 50 per cent cost sharing arrangement with TMR. Such a basin will not meet VMR Burdekin's request for 27-metre width of navigable creek at a tide height of 1.4 metres.
- Owing to creek width, such an expanded basin will still place tidal height restrictions on the length of boat being launched or the timing of launching a boat like the larger of VMR Burdekin's two vessels. One is 7 metres and the other 11 metres length overall.

- TMR can assess a staged future facility upgrade to include a berthing pontoon on the
  upstream side of the upgraded ramp. The viability of a future pontoon would depend on
  infill rate and infill extent of the dredged basin experienced over the next couple of
  years. Therefore, a pontoon cannot be committed to now, TMR can only commit to an
  ongoing feasibility assessment.
- A floating walkway style pontoon, as proposed by VMR Burdekin, is not feasible as it
  would impede navigation in the narrow creek and creating sedimentation at the ramp,
  due to absorption of tidal flow energy.

TMR and BSC understand VMR Burdekin is different from most VMR groups in that it responds not from a foreshore base, but by road towing one of its two vessels to the nearest appropriate boat ramp in the Burdekin region.

VMR Burdekin may need to consider:

- restricting operations from Ocean Creek to the smaller of its two vessels (7-metre one, and not the 11-metre one)
- selling its 11-metre vessel and purchasing a vessel suitable to Ocean Creek operations
- dedicating a vessel to Ocean Creek operations and keep it on a mooring in the larger creek further downstream and accessing the moored vessel from a dinghy launched at most tides from the Ocean Creek boat ramp.

I trust this summary will help in your considerations for upgrading the boat ramp.

#### G'day Vince,

Please find responses to your previous comments sent in late Nov last year (sorry for the delay in getting back to you on this).

- 1) It would be helpful if the new ramp ended further Westward than at present, this will allow more room between the bottom of the ramp and the Eastern bank for larger vessels to manoeuvre at lower tides. Without being fully in a cut this is not possible. Ramp moved westward (cut) will lead to more siltation and slippery surface which is not advisable. However, the toe of new ramp will be at LAT (much deeper than the present toe) and it will be away from the existing scour hole. The slope is steeper and 1: 8 similar to all new TMR boat ramps. All these improvements will help deeper draft vessels to launch easily.
- 2) If the new ramp was positioned on a downstream angle, it may not be so prone to siltation and debris build up. Changing the orientation of the ramp will involve filling in to the tidal land and also council has to build new trailer turning area in the existing tidal land. This is very costly and require new approvals from

- authorities which will take a long time. Current budget and project delivery time frame do not allow us to do any changes to the orientation of the ramp.
- 3) Is it possible to allow for future development for example the installation of a pontoon? It will be possible to widen the ramp in future. However there is no opportunity to place a pontoon in this location due to the restricted water depths.
- 4) At present the sandy spoil from the bottom of the ramp is deposited on the upstream side of the ramp, this gives us a clear area to beach vessels, we would like this to continue. We will not touch this sand in the current proposal. Any sand excavated from the toe of the new ramp can also be placed in the same area if required.
- 5) The area around the top of the ramp should be built up higher than at present, but please do not have a hump similar to the Groper Creek ramp, larger trailers will bottom out. The new ramp is designed to have HAT as the top level. This will require some filling in the access road and boat trailer turning area by the local council to avoid a hump situation.

I refer you to the attached design long section for review. The new profile is 200mm above the current profile to reduce the accumulation of silt. The toe of the ramp is extended beyond the existing ramp to improve tidal access but follows the existing creek bed at a 1 in 4 slope. This way, vessels will have almost the same level of water access but the trailer can be backed more into the water due to the longer planked ramp length. There will be some siltation onto the ramp but still a trailer can reverse without too many issues. We can also put concrete wheel stops at the end of the ramp to stop trailers going off the end of the ramp into the mud, given the end of the ramp will be steeper.

#### Good Morning Peter

I circulated your email and plan to our rescue vessel skippers and there seems to be no problem with the survey levels and proposed grade of the new ramp. There have been a couple of suggestions regarding the position of the new ramp.

- 1) It would be helpful if the new ramp ended further Westward than at present, this will allow more room between the bottom of the ramp and the Eastern bank for larger vessels to manoeuvre at lower tides.
- 2) If the new ramp was positioned on a downstream angle, it may not be so prone to siltation and debris build up.
- 3) Is it possible to allow for future development for example the installation of a pontoon?
- 4) At present the sandy spoil from the bottom of the ramp is deposited on the upstream side of the ramp, this gives us a clear area to beach vessels, we would like this to continue.

5) The area around the top of the ramp should be built up higher than at present, but please do not have a hump similar to the Groper Creek ramp, larger trailers will bottom out.

On the issue of closing the facility completely during construction, Marine Rescue would be able to continue operation from alternate sites with longer response times, however this facility is very popular and there would probably be some disgruntled local boaties.

Can you give any indication of how long it will be until the project is completed?

G'day Vince,

Thanks for the chat earlier today. Please find attached the hydrographic survey for the boat ramp, which was done in June this year. As mentioned the survey has used the tidal plane information for Oyster Rocks, Burdekin River. Note the survey is in Aust Height Datum (AHD), with the Lowest Astronomical Tide (LAT) and Highest Astronomical Tide (HAT) levels shown in the small table on the bottom right side of the survey plan.

Our thoughts are to increase the height of the top of the ramp and start it back up the gravel access road a bit and rebuild the new ramp at a slope of 1 in 8 (the existing ramp is about 1 in 11) and extend the ramp into the creek to about LAT level (i.e about down to the 1.5m AHD contour).

The new lanes will be 4 m wide, with 750mm rock grouted shoulders on each side, so the new ramp will be slightly wider than the existing one.

I would appreciate any comments you and your members have on the HAT and LAT levels shown in the survey and whether they appear accurate to what is actually happening at the site. Any comments on our initial design thoughts would also be welcomed. Please call me if you have any questions. Thanks.





I refer to previous correspondence with President Vince Papale and other Squad representatives.

At our recent general meetings the Burdekin Squad resolved the following suggestions for the future development of the Ocean Creek boat ramp facility.

Ocean Creek Landing - Following the recent grounding of our primary rescue vessel at the landing. The squad resolved to ask the Burdekin Shire Council and the Queensland Department of Transport to consider the following when looking to further development of the Ocean Creek facility.

The facility should be scheduled for a staged upgrade to bring it to a standard capable of launching, retrieving and provide temporary mooring for vessels up to ten meters in length.

The following points are raised for consideration.

- Old Ramp Leave the old dual lane ramp where it is as an alternative access point during times of high use of the facility.
- That a second dual lane ramp be considered for a site approximately 20
  metres downstream from the current ramp with access to the current carpark.
  The squad considers that this second site would be less prone to siltation as the site is situated on the outside corner of the creek.
- **Siltation** is expected to be an ongoing issue that will need to be addressed by an appointed authority on a regular basis.
- The facility should provide sufficient depth and room to manoeuvre a ten
  metre vessel successfully at 1.4metres of tide and above. To facilitate this, the
  squad suggests that the ramp area of the creek be widened to the west to give
  at least a width of twenty-seven metres of navigable water at 1.4metres of tide.

(The launching basin currently measures approximately seventeen metres wide from the base of the current ramp.)

- A mooring pontoon with bollards should be constructed between the bases of both ramps.
- **Walkways** should be constructed from the carpark to both ends of the mooring pontoon adjacent to the ramps. Bollards placed along the walkways to assist control of vessels during periods of high tidal flow.

This Squad thanks you for your forbearance to this point and looks forward to working with you in the future development of a facility for Ocean Creek that better caters for current and future community expectations of the facility.

RE: Addressing Queensland's drink container and plastic litter and recycling problems through Container Deposits and restrictions on plastic packaging

Dear Mayor and Councillors,

Boomerang Alliance is a community-based network advocating for waste reduction and resource recovery. We are active right around Australia and in recent times, our activities in NSW have led to the State Government deciding to introduce a container deposit scheme in 2017 (further information about us below).

We write regarding the investigation into a container deposit scheme (CDS) currently being conducted by the Queensland state government. We believe that this investigation is a positive first step and could be harmonised with NSW.

We also support the government's proposal to restrict the use of single use plastic bags and other problematic plastic packaging. These measures are also the subject of current government considerations, with a public discussion paper expected next year.

We note that the LGAQ Conference supported both of these measures in October 2014.

Studies in Moreton Bay have found that the ingestion of plastic debris was responsible for about 30% of all turtle deaths, with a further 6% of deaths due to entanglement. Recent data from the state government shows that 70% of loggerhead turtles found dead in Queensland have ingested plastics. Thousands of sea birds also die along the coast as a result of plastic ingestion or entanglement. The CSIRO estimates that 95% of all Australian seabirds will have ingested plastics, within three decades.

The Great Barrier Reef Outlook Report 2014 has identified marine debris and plastics as a major problem for the health of the reef. Studies show that corals eat microplastics, causing slow death from starvation. The Long Term Sustainability Plan for the Great Barrier Reef registers marine debris as a threat that must be addressed.

#### **Our Solutions**

The tried and proven approach to reducing litter and plastic pollution is the banning of single use plastic bags and the introduction of container deposits for beverage containers. Boomerang Alliance also supports measures to phase out microplastics, such as microbeads and prevent the escape of nurdles.<sup>1</sup>

The CSIRO Marine Debris Report (2014) observed that:

'The most effective way to reduce and mitigate the harmful effects of marine debris is to prevent it from entering the marine environment: cleaning up our oceans is a much less practical solution.'

'We also evaluated the effectiveness of incentive schemes, such as South Australia's container deposit scheme, in reducing waste lost into the environment. The scheme appears to be very successful, reducing the number of beverage containers, the dominant plastic item in the environment, by a factor of three.'

The banning of plastic bags would immediately remove an estimated 800 million-1 billion bags used in Queensland every year. Along with introducing container deposits - plastic litter would drop by over 70% and raise bottle and can recycling to 80%. It would generate millions of dollars in revenue for resource recovery and provide a significant financial boost for both local government and community organisations.

A January 2015 Newspoll commissioned by Boomerang Alliance, showed 85% support for a container deposit scheme in Queensland. A recent Omnipoll (August 2015), found that 73% of Queenslanders were concerned about the environmental impacts of plastic litter and a majority backed a ban on plastic bags.

With the NSW Government committed to introducing a container deposit scheme, there is a once-in-a-generation opportunity for Queensland to join with NSW and expand a container deposit scheme across both jurisdictions.

<sup>&</sup>lt;sup>1</sup> Microbeads are tiny plastic pellets used as abrasives in cleansers unable to be captured in STPs; nurdles are the small plastic resin balls used to manufacture plastic products that are flushed into the stormwater system from factories.

The Boomerang Alliance and our allies are keen to canvass your views on a container deposit scheme and other measures for Queensland.

We would appreciate your views on whether:

- a) Your Council supports the introduction a container deposit scheme in Queensland.
   b) Your Council supported the motion presented at the LGAQ Conference in October 2014?
- 2. If your Council is opposed or undecided, your interest in further dialogue with the Boomerang Alliance, to exchange views on the value of such a scheme.
- 3. Given that the LGAQ Conference 2014 unanimously backed a motion to restrict plastic packaging and bags, your Council supports the banning of single use plastic bags (and, where possible, other problematic plastic packaging).
- 4. Your Council supports national and state-based initiatives to phase out identified microplastics.

We believe it's time for Queensland to act on litter and rubbish, in particular plastic debris. However, it is imperative that local governments in Queensland are part of that agenda, to both support effective measures and, where appropriate, assist in their implementation. We would value your Council's response and participation in this important public debate. As a first step, we would welcome your response to the questions posed.

- The State Government has announced an investigation into CDS for QLD.
- NSW has announced the introduction of a scheme in 2017.
- Data from South Australia (and other overseas jurisdictions) shows that CD slashes litter and dramatically increases recycling.
- It also shows that with a 10cent deposit about 80% of people participate in the scheme by returning containers. The unredeemed deposits help fund the system.
- A cost effective CDS in QLD can operate on a sustainable business model without government monies.
- CDS also provides a financial boost for community organisations interested in collection of cans and bottles. Scouts in SA receive \$40 million every year from involvement in the scheme.
- CDS can support Council recycling by reducing kerbside collection costs and by allowing Council to claim deposits from cans and bottles left in kerbside.
- Where no kerbside collections exists, CDS can fund collection infrastructure for residential and SME's.
- Council can also claim deposits from containers left in public place bins.

#### Who is Boomerang Alliance?

The Boomerang Alliance was formed in 2003 with the aim of a zero waste society. Our first target was packaging, in particular beverage containers. Since then we have also worked on waste tyres and lobbied for a national waste policy.

We successfully campaigned for a national electronic waste recycling program (involving all brands) and are watching moves towards waste to energy very closely.

Our current primary focus is marine pollution and debris, particularly plastic pollution. This includes the introduction of a container deposit scheme for beverage containers in each state and action on single use plastic bags and packaging – all of which are important steps in changing behaviour and reducing our impacts on the marine environment
