I am pleased to advise that the Honourable Jackie Trad MP, Deputy Premier, Minister for Infrastructure, Local Government and Planning and Minister for Trade and Investment recently announced the release of the 2016-17 application based Grants and Subsidies Programs (the programs) which consists of the following:

- Community Resilience Fund
- Local Government Grants and Subsidies Program
- Natural Disaster Resilience Program (NDRP).

The total 2016-17 funding for the programs is \$62.3 million, of which, \$12 million is provided by the Australian Government under the NDRP. The programs provide funding assistance to eligible applicants for disaster mitigation and resilience and key infrastructure projects and in 2016-17 the Deputy Premier has approved an increase in the level of grant subsidy from 40 to 60 per cent of eligible project costs.

In order to minimise the administrative burden and facilitate timely disbursement of funds, the 2016-17 programs have been consolidated into a single set of guidelines, with a single Expression of Interest (EOI) application form.

EOIs for funding under the programs will close on **28 September 2016**. While this represents a shorter timeframe, I am confident the challenges it provides can be met with the assistance of departmental officers.

The relevant guidelines, EOI form and Certification Form are available on the Department of Infrastructure, Local Government and Planning's website, www.dilgp.qld.gov.au.

Local infrastructure funding package: Closing date for EOI 28 September 2016

The LGAQ has welcomed the \$70 million local government funding package announced by the Queensland Government on 9 September 2016.

The package comprises \$50 million for grants (Local Government Grants and Subsidies Program, Community Resilience Fund and Natural Disaster Resilience Program) and \$20 million for feasibility studies to get projects investment ready. The funding is reserved for local governments except for the Natural Disaster Relief Program which is also available to other eligible organisations including not for profits.

The LGAQ has been working with the government to streamline the grants and subsidies process and made a submission to the government in March 2016 to commence that process.

Through LGAQ advocacy, we have achieved a number of improvements to the applications process:

- Two-stage application Expression of Interest (EOI) and then full application to save councils time where projects are not eligible for funding;
- Increase of subsidy from "up to 40%" to "up to 60%" recognising the difficulty many councils face in co-contributing to projects;
- The Department of Infrastructure, Local Government and Planning (DILGP) will allocate the
 project to the appropriate funding program rather than councils having to worry about which
 program their project fits with. This will allow for better allocation of resources and more
 funding opportunities;
- All three programs being announced at once for better planning rather than ad hoc announcements throughout the year; and
- Shorter turn around for applications.

The guidelines for the 2016-17 grants and subsidies programs are available on the DILGP website. Councils should note that the closing date for EOI is Wednesday 28 September 2016. Notwithstanding the short timeframe in which to develop an EOI, DILGP will work with councils in the preparation of EOIs and, if approved, the subsequent development of the necessary submission/business case. The LGAQ supports this approach by the department.

The LGAQ also welcomed the \$20 million Maturing the Infrastructure Pipeline Program, part of the \$2 billion State Infrastructure Fund, to assist councils fund feasibility studies/project evaluations for infrastructure projects that support economic growth.

As noted in the LGAQ media release, the Association has renewed its call on the Federal Government to come to the table in terms of funding for natural disaster mitigation. The State Government has invested \$50 million in two years plus a 20% plus co-contribution from councils. The LGAQ Policy Plan for the July Federal Election called on federal political parties to match state funding on a 40:40:20 basis, but there is still no commitment from the new Government. Ultimately these projects will save taxpayers in the long run by enhancing the resilience of local government infrastructure, \$5.4 billion of which was damaged in the last decade. The LGAQ will continue to lobby the federal government over the coming months.

I am pleased to announce the publication of the North Queensland Principal Cycle Network Plan (PCNP). PCNP has been developed in collaboration with Burdekin Shire Council (BSC) officers, reflecting their recommendations. The plan can be found on the Department of Transport and Main Roads (TMR) website at www.tmr.gov.au, click on (1) 'Travel and transport', (2) 'Cycling'.

PCNPs reflect a 'one network' approach to cycle network planning and show core routes needed to get more people cycling more often. Routes shown are indicative and exist to guide further planning. PCNPs are intended to support, guide and inform people involved in the planning, design and construction of the transport network.

BSC has also worked with TMR to prioritise delivery of routes identified in PCNP. Priority Route Maps (PRMs) will form an addendum to PCNP and guide investment in the principal cycle network by both BSC and TMR over the next 10 years. My Director-General, Mr Neil Scales, has recently written to your Chief Executive Officer requesting formal written endorsement of PRMs for your council.

Links to grant funding

Following your recent endorsement of PCNP, BSC is eligible to apply for funding for delivery of cycling infrastructure projects under the Queensland Government's Cycle Network Local Government Grants program. PRMs will inform TMR's assessment of applications under the program, with higher priority routes generally being given greater weighting.

I wish to thank you for your ongoing participation in the development of the principal cycle network in the North Queensland region.
