## Dear Councillor McLaughlin

Queensland has legislation in place for the safety of all road users and to assist the efficient flow of traffic. The Department of Transport and Main Roads has implemented a legislative change to the Queensland Road Rules (QRR) to assist those with a disability and their families, friends or carers by extending the time limit to park in a loading zone.

The QRR provide that a driver may stop for up to two minutes in a loading zone to pick up or set down passengers. The legislative amendment provides that the two-minute time limit is extended to five minutes for a driver who is setting down or picking up a passenger with a disability in a loading zone. It is anticipated that this extension to five minutes will provide a person with a disability, sufficient time to perform actions that relate to being picked up and set down. The two-minute time limit will remain for the setting down and picking up of other passengers who do not have a disability.

The legislative amendment commenced on 16 December 2016. More information about this amendment is available at https://www.legislation.gld.gov.au/LEGISLTN/SLS/2016/16SL240.pdf.


