The Association welcomed the State Government's commitment to zero waste. "Local councils across Queensland are hurting, and we will work quickly and collaboratively with the Government to ensure the best possible strategies are put in place," said Greg Hallam, CEO.

### **Talking Points**

- The Queensland Government has committed to a zero waste to landfill, and waste to energy strategy after discussions with LGAQ.
- It has also announced the waste levy will be included in the coming budget.
- This follows Ipswich City Council's difficult decision to abandon recycling.
- LGAQ will be front and centre in discussions to bring forward the waste levy to January 1st, 2019.
- LGAQ opposes a landfill levy on domestic waste.
- LGAQ doesn't support the expansion of the council areas to be subject to the levy.
- Levy proceeds shouldn't go into State consolidated revenue. It should go to the councils, the recycling industry
  and to fund world class energy plants.
- This will position Queensland as a global leader in waste management, and will be good for our children, children's children, and generations to come.
- LGAQ will continue talks with the Government and other stakeholders.
- LGAQ will consider an overseas study for interested councils to visit well established plants as soon as it is
  practical to do so.
