The Department of Transport and Main Roads (TMR) has introduced new measures for oversize heavy vehicles to safely cross the Burdekin River Bridge (BRB), Home Hill both northbound and southbound.

Oversize heavy vehicles over 3m wide or 4.6m high (northbound) or 4.5m high (southbound) are now required to call the TMR Traffic Management Centre (TMC) on 13 19 40 before crossing the bridge.

As of Friday 31 March 2023, TMC will centrally control the bridge crossing traffic signals to allow oversize heavy vehicles to safely cross the BRB.

The new procedure will ensure the safe crossing of the oversize heavy vehicle, minimise inconvenience to other motorists while the bridge is closed and ensure no damage is caused to the heritage infrastructure.

This change has occurred because TMR will now be the sole agency responsible for controlling the traffic signals on the BRB.

The oversize heavy vehicle operator will still be responsible for organising and paying for an escort service.

Three new road signs were installed on Thursday 30 March 2023, at the northern and southern approach of the bridge respectively to replace the current oversize vehicles notices, as part of the escort program.

The first road sign has remained unchanged and still reflects the times oversize vehicles are prohibited from crossing the Burdekin River Bridge.

The second road sign now instructs oversize heavy vehicle operators to contact TMR on 13 19 40 to arrange for traffic signal activation.

The third road sign has been updated to reflect the oversize vehicle height and width.

## Notice to heavy vehicle operators

The Department of Transport and Main Roads (TMR) would like to advise that operators of heavy vehicles over 3m wide or 4.6m high (northbound) or 4.5m high (southbound) are now required to contact the TMR Traffic Management Centre (TMC) on 13 19 40 before crossing the Burdekin River Bridge (BRB), Home Hill. This change has occurred because TMR will now be the sole agency responsible for controlling the traffic signals on the BRB.

## Am I impacted?

The traffic signals located on the approaches to the BRB will now be centrally operated by the TMC to maintain road safety when larger loads and vehicles cross the bridge.

Operating the signals will maintain the safe and efficient flow of traffic, minimise inconvenience to other motorists and ensure that no damage is caused to other road users and the overhead bridge structure.

## How can I prepare?

- 1. Both the operator and driver have the responsibility to check TMR's Conditions of Operation database before any trip.
- 2. Have the accreditation licence number of the vehicle escort operator assisting with the transport of the oversize load across the BRB.

Note: BRB has a condition currently in place for oversize vehicles over 3m wide or 4.6m high (northbound) or 4.5m high (southbound).

At the very minimum, oversize vehicles must be accompanied by an accredited escort vehicle operator when crossing the BRB.

## I'm ready to cross

When you are ready to cross the BRB, the oversize heavy vehicle operator or escort vehicle operator must contact the TMC on 13 19 40.

TMC will activate the traffic signals and the oversize heavy vehicle can cross the BRB.

<u>Note:</u> Oversize heavy vehicles will still be prohibited from crossing the BRB from 7.30am – 9.00am and 3.00pm – 4.30pm Monday to Friday.

## When is it happening?

The changes will take place from Friday, 31 March 2023.

New signs will be installed in the pull over areas on both northbound and southbound sides of the BRB to remind oversize heavy vehicles operators of the escort procedure.

## Who engages the escort vehicle operator?

All arrangements and payments for the transport of an oversize load over the BRB are to be made directly with the company providing the service.

## Re: Local Government Remuneration Commission council category review

The Local Government Remuneration Commission (the Commission) is required under the *Local Government Regulation 2012* to establish remuneration categories for local governments and undertake a review of the established categories once during each local government term ('a category review').

The completion of a category review is in addition to the Commission's annual requirement to determine maximum remuneration amounts for mayors and councillors. For the current term of local government, the Commission's category review is required to be completed by 1 December 2023.

The review process, which is now underway, will include consultation with councils and other stakeholders during the first half of 2023 and the Commission anticipates having review outcomes finalised by October 2023.

The last change to the remuneration categories was in 2015. Since this time, the environment in which many councils operate has changed significantly, as have the requirements of mayors and councillors.

Through the 2023 review the Commission intends to ensure the methodology for determining local government remuneration categories is simple, equitable and transparent and reflects the circumstances impacting the roles of mayors and councillors across Queensland.

Given the importance of this review for the future and the workload involved to complete it in the time allocated, it would be opportune to have this matter placed before the council as soon as possible so it can be prepared for the consultation process when it starts.
