#### 1. Overview

#### 1.1 Purpose

This Transport Sub Plan aims to outline arrangements for the effective coordination of transportation resources to support the needs of the Burdekin LDMG and other community support groups to perform their emergency response, recovery and assistance tasks effectively.

#### 1.2 Objectives

The objectives of this sub plan are to:

- Identify appropriate transport requirements in the event of an emergency/disaster;
- Provide a complete list of local transport resources;
- Provide effective liaison between all emergency services and supporting agencies;
- Provide arrangements for efficient coordination of local resources and any external support resources; and.
- Prescribe arrangements for testing, evaluation and maintenance of this plan.

#### 1.3 Scope

This sub plan applies to emergency/disaster events occurring within the Burdekin Shire Council area, which are within the capability and resources of the Local Government, Emergency Services and other supporting agencies with a transport or evacuation function and/or responsibility.

#### 1.4 Authority to Plan

The Burdekin LDMG has prepared this sub plan under the provisions of section 57 of the DM Act. This sub plan will be managed in accordance with the administrative and governance processes outlined within the Burdekin LDMP including approval, document control, distribution, review and renewal.

### 1.5 Plan Review and Testing Requirements

This sub plan is to be reviewed annually before the severe weather season or post event to include lessons learned. This sub plan is to be exercised to ensure the effectiveness and scalability of the plan and include involvement, communication, and collaboration with identified key local, district and state stakeholders.

#### 2. Governance

#### 2.1 Activation of Sub Plan

This plan will be activated by the LDC of the Burdekin LDMG, where the nature of a risk to the community will require the movement of resources or at-risk persons to a safer location. This sub plan is supported by the:

- Burdekin LDMP;
- Burdekin LDMG Airport Emergency Sub Plan;
- Burdekin LDMG Communications Sub Plan;
- Burdekin LDMG Community Information & Warnings Sub Plan;
- Burdekin LDMG Evacuation Sub Plan;
- Burdekin LDMG Pandemic Influenza Sub Plan;
- Burdekin LDMG Public Health Sub Plan;
- Burdekin LDMG Resupply Sub Plan;
- Burdekin LDMG Tsunami Sub Plan;
- Burdekin LDMG Multi-Purpose Hall Place of Refuge Manual; and,
- Burdekin LDMG Local Disaster Coordination Centre Standard Operating Procedures (LDCC SOP).

The activation of these supporting plans should be considered concurrently with this plan.

A list of local transport resources will be maintained and reviewed regularly. See <u>Attachment A</u> of this document.

#### 2.2 Use of Sub Plan during Operations

The Burdekin Shire is susceptible to flooding from the Burdekin and Haughton Rivers and their associated waterways. Smaller settlements could be isolated due to flooding, cyclone damage, tidal surge or other road blockages, preventing contact with the larger towns for supplies, medical assistance, medical treatment or necessary evacuation. Transport assistance may be by road, rail, sea or air.

While disaster management at the local level is clearly the responsibility of the local governments, the disaster management system in Queensland involves a whole of government management framework with responsibilities shared between the state government, local governments and the community. One of the very important roles for Local Government in disaster management processes is the transportation of resources and people, as required by the particular event.

Refer to the Burdekin LDMG Resupply Sub Plan for detailed arrangements on resupply of goods and resources.

Refer to the Burdekin LDMG Evacuation Sub Plan for detailed evacuation arrangements.

#### 2.3 Functional Responsibility

The LDC is to ensure all agencies and members of the LDMG are aware of these procedures.

#### 3. Concept of Operations

A list of private companies engaged in the transportation of people and goods has been compiled to assess their availability in times of emergency. Although all companies responded positively, some stressed that they would not endanger their property or drivers in an event or if weather conditions were intolerable.

Council also has access to a large fleet of trucks and heavy equipment, both private and Council-owned. The database of privately owned vehicles and plant is available from Council.

#### 3.1 Roles and Responsibilities

Coordination of transport for evacuations for affected communities within the Burdekin Shire is the responsibility of the Burdekin LDMG through the Local Disaster Coordination Centre (LDCC), when activated.

Queensland Rail (QR) and the Queensland Department of Transport and Main Roads (DTMR) will provide support upon direction by the Townsville District Disaster Management Group (DDMG), as required following a formal Request for Assistance (RFA).

The role of the LDCC (Logistics, Planning, and Intelligence cells) shall be to assist in achieving the objectives of this sub plan by:

- Coordinating the provision of transport of personnel, equipment, supplies, and the public as required, in the event of a disaster or major event.
- Coordinating local traffic management plans (if deemed necessary).
- Maintaining information regarding the levels of locally available fuel during a disaster. The ability to supply fuel may be limited if there is a power failure.
- Providing reports and making recommendations to the LDMG about matters relating to transport disaster management issues.

#### 3.2 Support Agencies

The Burdekin LDMG will work closely with DTMR calling on other supporting agencies as required.

The following are the support organisations that may be called upon in the event of a disaster or emergency:

- Public transport contractors;
- Public sector agencies with suitable heavy vehicles;
- Private Bus companies;
- Private transport contractors;
- Taxi network;
- Airplane/Helicopter contractors;
- Voluntary agencies with transportation vehicle;
- QR:
- State Emergency Services (SES);
- Volunteer Marine Rescue (VMR)
- Marine Rescue Queensland (MRQ)
- Queensland Fire Department (QFD); and,
- Wilmar Sugar Industries

The provision of transport resources in response to an event requires maintaining information about the resources available locally. This information will be reviewed and updated at least annually and if possible, before every "wet" season commencing from November.

#### 3.3 Media and Public Information Arrangements

Emergencies and disasters are likely to draw significant media interest to provide information. The response to requests needs to be coordinated through the Media Liaison Officer and is the responsibility of the Chair and Local Disaster Coordinator. The Chair of the LDMG is the spokesperson.

#### 3.4 Remote and Isolated Communities

In the event of a disaster/emergency impacting the region, consideration also needs to be given to transport requirements for remote and isolated communities. The Local Area Warden (LAW) Program will be used to contact personnel in the affected areas to determine the community's needs.
