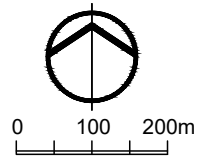

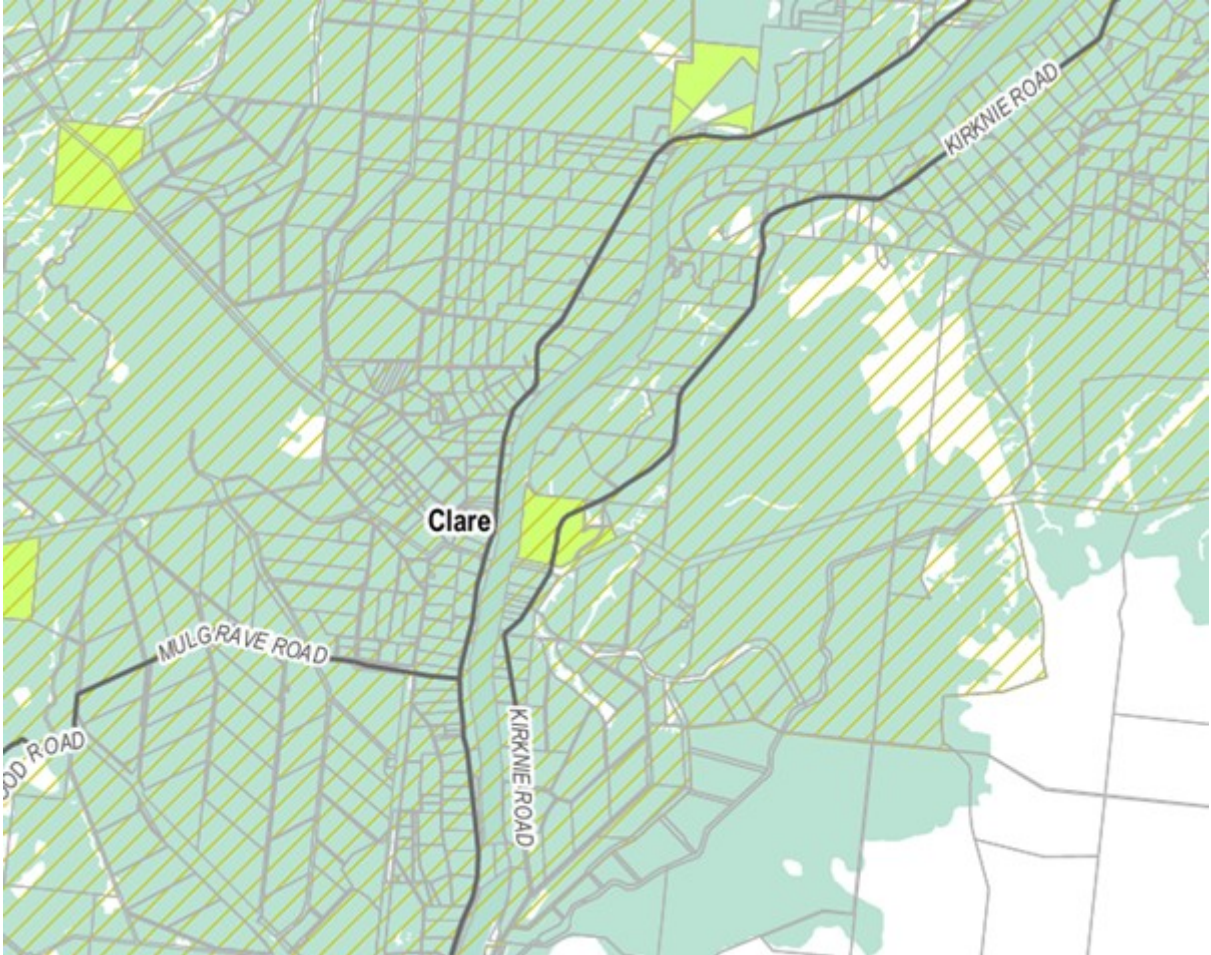

PLANNING REPORT

Reconfiguring a Lot (Subdivision)

Lot 1 on SP203334, Ted Walsh Road, Kirknie

1. Introduction

This Planning Report has been prepared in support of a Development Application for a **Reconfiguring a Lot (Subdivision)** over land described as **Lot 1 on SP203334, Ted Walsh Road, Kirknie**.

The application seeks to create two (2) rural lots from one existing lot.

The proposed subdivision will excise an area of approximately **58 hectares**, with the balance lot retaining the remainder of the parent parcel.

2. Site Description

The subject land comprises a large rural holding currently utilised for agricultural purposes, including cattle production.

The proposed excised lot contains established rural infrastructure, including:

- Cattle handling yards
- Cattle feeding and holding infrastructure
- Agricultural storage shed and silos
- Water tank
- Effluent/settlement dam
- Internal access tracks

The land also contains areas of remnant vegetation, primarily located toward the southern and western portions of the site.

There is **no dwelling located on the proposed lot**.

Access to the land is provided via an existing constructed access connecting to a **council-maintained road (Heatley's Rd)**.

The land is not subject to known flooding constraints.

3. Proposal

The application proposes a **Reconfiguring a Lot (Subdivision)** to create:

- **Lot 1 (proposed):** ~58 hectares
- **Balance Lot:** remaining area

The proposed lot is intended to continue to be used for **agricultural purposes**, including cattle grazing and associated rural production activities.

The proposed boundary reflects the **existing operational footprint of the established agricultural infrastructure** on the site.

4. Planning Framework

4.1 Zoning

The subject land is located within the **Rural Zone** under the Burdekin Shire Planning Scheme.

The Rural Zone supports:

- Agricultural production
 - Animal husbandry
 - Rural industries

4.2 Priority Agricultural Area

The land is identified within a **Priority Agricultural Area**.

Within this designation, subdivision to a minimum lot size of **30 hectares** is supported.

The proposed lot size of approximately **58 hectares** is therefore compliant with the applicable minimum lot size requirements.

5. Existing Development Approval

The subject land contains an existing and lawfully established rural industry.

Development Approval **MCU19/0007** was granted by Burdekin Shire Council on **24 September 2019** for:

Material Change of Use – Intensive Animal Husbandry (Cattle Feedlot)

The approval applies to **Lot 1 on SP203334**, being the subject land of this application.

The approved development includes:

- Cattle feeding and handling infrastructure
- Storage and operational facilities
- Water and waste management infrastructure

Council's assessment of the application determined that:

- The development would not cause significant adverse impacts
- The use is compatible with surrounding rural land uses
- The development is appropriately buffered and located

The proposed subdivision:

- Does **not seek to intensify or expand** the approved use

- Maintains consistency with the existing approval

6. Reconfiguring a Lot Code

The proposal is consistent with the intent of the Reconfiguring a Lot Code as it:
